REPORTS:

The Board voted unanimously to accept the four-page **Clerk's Report of June 9**, as edited (see attached). The clarifying sentences were: "The business-on-line bank FOB shall be assigned to the Treasurer, Nancy Fritz. This FOB allows on-line access to all accounts held by UUCC at Kennebec Savings Bank, including the ability to view accounts and to transfer money between accounts." Former Clerk Karen Foust also inserted edits suggested by Kathy Ann.

There was no **Treasurer's Report.** Nancy Fritz reported that the church officials were still recording July expenses attributed to 2021, and a small carryover for the next fiscal year may result. She also reported that Marilyn Dunn, Invested Funds chair, has been given access to the church's Endowment accounts.

The Board voted unanimously to accept the motion proposed by Nancy Fritz, and seconded by Harry Grimmnitz, that, "Effective August 1, 2022, the only two authorized signatories for the UUCC Minister's Discretionary Account will be Christina Sillari (Minister) and Nancy Fritz (Treasurer)."

Finance Committee's Report: Harry Grimmnitz reviewed the June meeting held at Nancy Fritz' outdoor venue and said that introducing the new UUCC bookkeeper, Louise Allen, was helpful. The Treasurer pointed out to the Board that the Rev. Carie Johnsen Social Justice Fund will be self-sustaining at \$25,000 in value. Ministerial Support Plan Update:

She will offer Sunday services from the pulpit twice a month -- from September to June (including Christmas Eve). Her contracted additional work includes Pastoral care and staff supervision.

The Board discussed at length the future settled Ministerial needs of the UUCC.
