

# *Dinner for Two Anywhere in the World*

## **UUCC Raffle Terms and Conditions**

**Unitarian Universalist Community Church of Augusta (UUCC)

A designated representative of the Unitarian Universalist Community Church of Augusta (UUCC) will conduct the 2018 “Dinner Anywhere in the World” Raffle drawing at UUCC on Tuesday, January 1, 2019, at noon. We will notify the person who purchased the selected raffle ticket (the “Winner”) by phone and/or email, as provided on the winning ticket stub, on Wednesday, January 2, 2019.

The Winner is entitled to two round-trip airline flights to and from any major airport, dinner for two at the restaurant of choice, and a two-night stay at a hotel for two, up to a total package reimbursement value not to exceed Five-Thousand Dollars (\$5,000), (the “Prize”). The Winner will have two months time to choose cash or travel Prize, up to and including March 1, 2019. The alternative prize, if chosen, is a cash prize equal to THREE THOUSAND DOLLARS (\$3,000.) UUCC will pay the cash prize to the Winner by check within two weeks from the time UUCC receives a written notice from Winner that a cash prize has been selected.

The Winner may extend travel dates at his or her own cost and expense. The Prize does not include bush flights or ground transportation, alcoholic beverages, or any other entertainment or services beyond those explicitly stated in these conditions. The total travel Prize reimbursement is not to exceed FIVE THOUSAND DOLLARS (\$5,000). The Winner must use the Prize by July 1, 2020. All travel arrangements must be booked through a designated agent.

- The Winner must be at least 21 years of age and may be required to provide proof of age to UUCC.

- The Winner will receive a W-2G form from UUCC, and the value of the Prize will be treated as ordinary income to the Winner for federal and state income tax purposes. The Winner may be required to pre-pay a portion of the tax liability prior to receiving the Prize.
- Prior to accepting the Prize, the Winner may be required to provide to UUCC an IRS W-9 Form, a clear and readable photocopy of identification (such as a driver's license or passport), social security number, and any other required forms. The Winner represents and warrants to UUCC that all information submitted with respect to receipt of the Prize is complete and accurate.
- UUCC is not liable for any loss, injury, death, accident, theft, illness, or other misfortune of any nature whatsoever incurred during this trip or resulting from it. By accepting airline tickets or any other portion of the Prize, the Winner releases UUCC, its employees, directors, agents, and attorneys from any and all obligations to the Winner and any and all claims or causes of action that may exist against UUCC, known or unknown, as well as any such obligations, claims, or causes of action arising from the Winner's acceptance of the Prize. UUCC makes no warranty whatsoever, express or implied, with respect to the Prize.
- The IRS takes the position that no portion of the ticket price will qualify as a charitable contribution for federal income tax purposes.
- UUCC will apply net raffle proceeds to servicing the public benefit of the community by working toward the fulfillment of its mission.
- Tickets cost TWENTY DOLLARS (\$20.00) each and may be purchased by cash or personal check. Each ticket buyer must write purchaser's name, telephone number or email address on each ticket.
- Raffle tickets may not be deposited in the federal postal service; doing so is a violation of federal law and may lead to penalties.
