



Our Interim Minister search is on its way and has started this week with the development of a Search Committee. The Committee exists of three board members and two congregants (see below). They will work with the Unitarian Universalist Association (UUA) Transition Office to review and interview candidates from the region and beyond. A comprehensive application is submitted by the Committee to the Transition Office by April 22nd, after which interested candidates are presented to the Committee for review. The finalists are ultimately interviewed to begin on August 1st for a term of two-years. In the meantime, the Worship Arts team is undergoing their own process to consider a Worship Minister to support their ministry and lead Sunday services from May 17th to August 1st.

EMBODY OUR PRINCIPLES WITH MUUSAN

The Maine Unitarian Universalist State Advocacy Network (MUUSAN.org) creates opportunities for each of us to put our religious values into practice with the State Legislature. MUUSAN is a network of people from our congregations across Maine who follow the activity when the legislature is in session and invite interested people to take action such as writing letters or making phone calls at significant moments in the process of making laws.

MUUSAN is organized into four issue groups, each one rooted in our seven principles.

The **DEMOCRACY IN ACTION** group promotes our fifth principle, the right of conscience and the use of the democratic process within our congregations and society at large.

The **HEALTH CARE** group promotes our second principle, justice, equity and compassion in human relations.

The **CLIMATE CHANGE** group promotes our seventh principle, respect for the interconnected web of all existence of which we are a part.

The RACIAL, NATIVE AND IMMIGRANT JUSTICE group promotes our first principle, the inherent worth and dignity of every person, the second principle cited above, and the sixth, the goal of world community with peace, liberty and justice for all.

Connecting with any of these groups will give you an opportunity to join your voice and your values in a meaningful way.

Dr. Don on COVID-19 The New Johnson and Johnson Vaccine

Last Saturday twelve members of the Advisory Committee on Immunization Practices endorsed the J&J vaccine, with none voting against and a single member recusing due to potential conflicts. The vote came after the FDA authorized emergency use of the shot for adults 18 and older. CDC Director Rochelle Walensky signed off on the recommendation shortly after the vote. "This vaccine is also another important tool in our toolbox to equitably vaccinate as many people as possible, as quickly as possible," Walensky said in a statement.

The Johnson & Johnson vaccine is the first single-dose shot authorized in the U.S. That means no follow-up visits, none of the red tape needed to make sure people return for those second shots, and none of the worry about making sure a second dose is available at the right time. It requires no deep cold for storage and transportation making it especially useful in rural communities and for hard-to-reach populations.

The shot was found to be 66 percent effective in preventing moderate to severe Covid-19 at least 28 days after vaccination, and 85 percent effective in preventing severe to critical Covid over the same time frame, according to the FDA. Four weeks after the shot, data from the clinical trial participants showed there were no hospitalizations or deaths. This response is two weeks faster than the two vaccines in current use.

The J&J vaccine's efficacy rate is lower than both the Pfizer and Moderna shots, however, public health officials warn the rates don't offer apples-to-apples comparisons. The J&J trial may offer a better measure of how the company's vaccine stacks up against new, more transmissible COVID strains that are proliferating around the world because the Johnson & Johnson vaccine was given in different populations and at a different time. It was tested in 44,000 people in the US, South Africa and Latin America months later in the pandemic than the Pfizer and Moderna vaccines. They were tested in the spring and summer before variant COVID began to show up.

Vaccine experts agree that all the vaccines provide very good protection by the most important measure, which is whether they keep people from getting seriously ill. "I think we need to pull away from this comparing and parsing numbers until you compare them head-to-head. Just be really grateful that we have three really efficacious vaccines," Anthony Fauci, the government's top infectious disease expert, said Sunday on ABC's "This Week."
