

They will work with the Unitarian Universalist Association (UUA) Transition Office to review and interview candidates from the region and beyond. A comprehensive application is submitted by the Committee to the Transition Office by April 22nd, after which interested candidates are presented to the Committee for review. The finalists are ultimately interviewed to begin on August 1st for a term of two-years. EMBODY OUR PRINCIPLES WITH MUUSAN

Are you interested in getting involved with lobbying Maine's legislature and wonder how to get started? MUUSAN is for you. The Maine Unitarian Universalist State Advocacy Network is already plugged in, and has a place for you.

As noted last week, you can choose one of the four advocacy areas and follow just that one, or you can keep up with all of them. At the beginning of the session, MUUSAN gets a list of all of the proposed bills that relate to Health Care, Democracy in Action, the Environment and Racial, Immigrant and Native Justice. The information is distributed to the relevant group and members decide how they will respond.

The group can endorse a bill, or not. If they decide to endorse a bill, they decide at which level to participate. A level 1 endorsement includes willing members submitting testimony, writing letters to the editor and encouraging direct connection between members of our congregations and their legislators. A level 2 endorsement involves all the same activities except submitting testimony. A level 3 endorsement is 'in name only' meaning that MUUSAN is listed as a supporter without the expectation that we will work for that bill. The same levels and activities apply if a group opposes a bill.

What this means for you is that your Congregational Legislative Liaisons can help you make a connection so you can get involved at any level that fits for you. Whether it's one bill or joining an advocacy group, you can have hands on involvement in making laws that promote our UU values.

Also, THIS SATURDAY MARCH 13, MUUSAN will hold its regular NETWORK MEETING from 10:00 until noon. SHENNA BELLOWS, our new Secretary of State will be speaking. The advocacy groups will also meet. FMI and to REGISTER and make the connection, visit MUUSAN.org.

Dr. Don on Covid-19

Dr. Don on COVID-19 About the Johnson and Johnson Vaccine

All three of the vaccines currently in use to prevent COVID-19 infection involve technology not previously utilized in the production of immunizing agents. The science behind each of these vaccines is well understood with some of its basic principles under study for over 75 years. The remarkable effectiveness of these new vaccines will undoubtedly lead to future vaccines using similar methodologies.

The Moderna and Pfizer vaccines use similar messenger RNA, or mRNA technology. When injected these vaccines deliver fragile genetic material incased in fatty particles that can be directly absorbed into our cells. This mRNA code taken up by cells in the arm muscle provides genetic instructions for protein construction. Our cells follow these instructions to make tiny pieces of protein that look like a part of the COVID virus. Completing the intact virus is not possible. These little proteins are "foreign" to us and stimulate an immune response, generating antibodies and immune cells that "remember" what they look like. This "anamnestic" (to not forget) response will be ready to defend us quickly in case of a new attack of virus having these same proteins.

The Johnson & Johnson vaccine uses what is known as viral vector technology. Instead of being carried in little lipid balls, more stable DNA genetic instructions are carried by a weakened common cold virus that can infect cells, but doesn't have the ability to reproduce itself and spread in the body to cause colds. Like the Pfizer and Moderna vaccines, this incomplete virus delivers genetic instructions to our cells only for building COVID spike proteins, the knob-shaped structure the virus uses to infect cells. Again these "foreign" proteins cause us to generate an immune system response.

The Johnson & Johnson's vaccine can be kept at simple refrigerator temperatures, making it easy to store, ship and handle. It is effective after only one dose, so health officials in some jurisdictions are considering offering it to those who may be hard to reach or who are otherwise unlikely to get a second dose. "I think in terms of one shot versus two shots, you can start thinking about underserved communities where it may be harder to follow up and ask people to come back for second shots," said John Wherry, director of the Institute for Immunology at the Perelman School of Medicine at the University of Pennsylvania. "You think about populations that are more transient that are harder to track."

The J & J vaccine shares important common qualities with the Pfizer and Moderna vaccines. None of the three vaccines contains additives that can sometimes cause strong reactions, such as antibiotics, preservatives or adjuvants, which are compounds used to boost the immune response of many vaccines. This means a very low risk of allergic reactions, especially life-threatening anaphylaxis. The CDC reports very few cases of anaphylaxis in people who have been given the Moderna or Pfizer vaccines, and all were easily treated. There have even less adverse responses to the J & J vaccine.

All three vaccines target a specific part of the spike protein called the "receptor binding domain". As the name implies, it's the part of the spike the virus uses to attach itself to cells for infection. Virus mutations that change the structure of this particular region could weaken the efficacy of all three vaccines. Luckily, all three appear to stimulate an overwhelming immune response, far stronger than people have after a natural infection. So far, it appears to be enough to continue at least partially protect people from current variants.
