

Update from COVID-19 Advisory Group

The plan for reopening UUCC for in-person, indoor gatherings approved by the Board on August 12, 2021 depends on the COVID-19 pandemic being under control in our state and county. The Board adopted a Maine CDC metric that measures "community (person to person) transmission" of the virus. The necessary CDC metric for us to reopen is no more than 10 new cases per 10,000 people in Kennebec County or the State of Maine.

The present CDC metric data indicates that it is still unsafe for us to safely reopen.

Dr. Don on COVID 19 COVID Rapidly Increasing in Maine Public Schools

According to the Maine Department of Education's dashboard, there have been 4,875 COVID-19 cases reported at Maine schools over the past 30 days, as well as outbreaks at 163 schools. The Gardiner Regional Middle School is a local case in point. According to Maine School Administrative District 11 Superintendent Patricia Hopkins, the school was forced to cancel classes on Monday due to a shortage of staff and numerous positive COVID-19 cases.

Hopkins said Monday in a message to parents that the school would switch to remote learning for the rest of the week. All other MSAD 11 schools will continue with in-person learning. "We ended last year anticipating that this year would be back to normal or more normal than it was last year, and in fact, it's actually been harder for most of us" Hopkins said. She said that nine or 10 students have COVID-19 and others are being tested and are waiting for results. She hopes the school will return to in-person learning on Nov. 22.

An elementary school in Freeport also shifted to remote learning this week due to increasing COVID-19 cases. Mast Landing School, which serves grades three to five, saw eight new cases of the virus last week and 20 cases over the past two weeks. "Due to these increased numbers and in consultation with the CDC, Mast Landing School will have remote learning next week (November 15-19). Pooled testing continues to go well in all of our schools. I encourage everyone to consider this option," Regional School Unit 5 Superintendent Becky Foley wrote in a letter to parents.

A health official with Northern Light Health said one reason for the spike in cases at schools is outdoor learning is being moved indoors with winter approaching. "The weather is getting a little bit cooler, so people are getting a little bit closer together than what they were a few weeks ago," said Suzanne Morsehead of Northern Light Health. "Viruses tend to spread a little bit more easily in cooler temperatures." Morsehead said basic hygiene practices, such as hand-washing and social distancing, can help limit the spread of the virus.

The Maine Department of Education said that increases in cases among the community will also lead to increases in cases at schools. Unfortunately Maine CDC reported 945 new cases of COVID-19 and 13 deaths on Tuesday, not new records but still some of the highest totals seen in Maine since the beginning of the pandemic. It seems likely increased cancellation of public school in-person classes will soon follow.
